








IMMOKALEE ADMINISTRATION CENTER IMMOKALEE, FLORIDA

The Immokalee Administration Center is a three-story administration facility in Collier County, Florida. The facility includes multi-purpose common areas, a commercial kitchen, a state-of-the-art heliport, executive office suites, conference rooms, boardrooms, and a library. The Seminole Tribe also uses this facility as a senior center for the Tribal Elders.





BIG CYPRESS PUBLIC SAFETY COMPLEX BIG CYPRESS, FLORIDA

Big Cypress Public Safety Complex is a 52,000 SF Emergency Operations Center. This complex houses more than two dozen staff members of the Seminole Tribe's Public Safety Department and the equipment for both police and fire rescue operations, as well as a U.S. Postal Facility.





THE Q CLUB HILTON FORT LAUDERDALE BEACH RESORT FORT LAUDERDALE, FLORIDA

As the Owner's Representative for the Developer of the Q Club Hilton Fort Lauderdale Beach Resort, we assisted with the final completion of the project, mechanical, electrical, plumbing and other punch list items. Also, some miscellaneous general contracting work was performed at the request of the owner.



DAVIE WATER/ WASTE WATER TREATMENT PLANT DAVIE, FLORIDA

The Davie Water/ Waste Water Treatment Plant project consisted of construction of a 6-million-gallon-per-day (MGD) brackish water membrane treatment plant as well as a 3.5-MGD membrane water reclamation facility. The project included construction of a new utility office for the town, a series of five raw water wells, two deep injection wells and reuse of the reclaimed water. The scope of work consisted of the structure package, comprising 14 buildings, including foundations, concrete, masonry, tilt-wall systems, roofing, windows and doors, structural steel, miscellaneous metals, stucco & EIFS and elevator systems.



MIRAMAR REGIONAL MULTI-SERVICE CENTER AND FIRE STATION 19

MIRAMAR, FLORIDA


The Miramar Regional Multi-Service Center & Fire Station 19 was completed for the City of Miramar under a GMP contract. In addition to the fire station, the 43,333 SF Multi-Service Center houses various city offices, bill pay centers and provides social services for senior citizens and city residents. The Fire Station replaced the trailers in which the Fire Department was previously located.















THE VILLAGE AT HAWKS CAY

DUCK KEY, FLORIDA

The Village at Hawks Cay project consisted of 247 residential units, which included landscaping, irrigation, plumbing, electrical, mechanical, and site work.

Originally built as residential villas, it has since transformed into a world class resort. The project was completed on time and under budget.









The Roosevelt Gardens project included 96 residential moderate income housing units in 17 different buildings. Our responsibilities involved design, master planning, and construction, which included site work, utility coordination, water mains and sanitary sewer, landscaping, playground areas, extensive erosion control and wetland mitigation.

The Dorothy Quintana Community Center was completed for the City of Miami. The Community Center provides a place for children and families to gather and provided much needed jobs to the community during the construction phase. The 9,200 SF facility includes public restrooms, covered terraces, and a playground area to serve the neighborhood activities and summer programs. In addition, the building houses the staff offices of the Park's Department and the Wynwood/Edgewater Neighborhood Enhancement Team. The project was changed to seek LEED Silver Certification after construction had commenced and ended up being certified LEED Gold.

KEY WEST, FLORIDA

The Truman Annex was a Construction Management project completed for Singh Company/ Village at Hawks Cay, Inc. The project's scope of work included the construction of 50 multi-family housing units on the former Truman Annex Naval Station. We were proud to have been a part of this award winning redevelopment, which includes a hotel, condos, apartments, affordable housing and the famous Little White House (The former vacation home of President Harry Truman).









Hyatt Beach House Resort's scope of work included site work, utility coordination, water mains and sanitary sewer, structural, mechanical, electrical, interior and exterior finishes, landscaping, and a swimming pool.





KEY WEST GOLF CLUB KEY WEST, FLORIDA



This Construction Management project is a private residential community nestled among the fairways and greens of the Key West Golf Club. There are 394 units in this planned unit development of varying size built over 46 acres.

The development also includes various amenities such as a resort pool, a small pool, playground, butterfly garden and a community center, which includes a fitness center, offices, and public restrooms.



JACKSONS BAR AND GRILL FORT LAUDERDALE, FLORIDA



Jackson Bar and Grill was a tenant improvement of a 7,200 SF space that was originally used as an office and restaurant. We worked in partnership with the owner's interior designer to meet the owner's schedule and design intent.









MIAMI METRORAIL CONTROL CENTER UPGRADES MIAMI, FLORIDA



Miami Metrorail Control Center Upgrade's scope of work involved the complete modernization of MDT's existing Metrorail Control Center (MRCC) to provide improved operations and maintenance of Metrorail facilities and systems in order to improve response times to critical safety and security events. The MRCC is located on the fifth-floor of the Stephen P. Clark Government Center building in downtown Miami.

This project included the development of existing office space to accommodate the modernization of the existing Central Control facility and systems, including the heating, ventilation and air conditioning (HVAC) system on the 3rd, 4th, and 5th floors, power distribution units, multiple server units/ banks, uninterruptible power supplies, electrical systems, and existing systems hardware and software. All work was performed while the Stephen P. Clark Government Center and the existing Central Control Center remained fully operational 24/7.
